The ICC Commission on Arbitration and ADR's Task Force on Decisions as to Costs is releasing a new Report. This is the Commission's latest initiative to ensure that ICC arbitration continues to be a viable and attractive form of dispute resolution for its users.

The objective of this Report is to inform users how arbitral tribunals may allocate costs with a view to controlling time and costs effectively and to assist in creating fair, well-managed proceedings which meet the expectations of users.

This research is included in Appendices to the Report
